D & R Campbell – Property Services Data Privacy Notice

1. Your personal data - what is it?

Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in the data controller's possession or likely to come into such possession. The processing of personal data is governed by the General Data Protection Regulation (GDPR).

2. Who are we?

D & R Campbell – Property Services is the data controller (contact details below). This means it decides how your personal data is processed and for what purposes.

3. What type of information do we hold about you?

D & R Campbell – Property Services collects and process information about many different people. This includes data we receive straight from the person it is about, for example, where they complete forms or contact us.

4. How do we process your personal data?

5. What is the legal basis for us processing your personal data?

As a business we have legitimate grounds for processing your data provided: -

- the processing relates only to current and past clients and
- there is no disclosure to a third party without consent.

6. Sharing your personal data

Your personal data will be treated as strictly confidential and will only be shared within the company to enable your work to be undertaken and billed. We will only share your data with third parties outside of the compay with your consent, unless the law requires us to do so.

We keep data for as long as it is required to provide the services requested by our clients. This includes access to historical information to better enable future works. Once a client stops using our services records are kept only to comply with accounting and tax requirements.

8. Your rights and your personal data

Unless subject to an exemption under the GDPR, you have the following rights with respect to your personal data: –

- The right to request a copy of your personal data which D & R Campbell Property Services holds about you;
- The right to request that D & R Campbell Property Services corrects any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data is erased where it is no longer necessary for D & R
 Campbell Property Services to retain such data;
- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing; If you have a concern about the way we are collecting or using your personal data, you should raise your concern with us in the first instance dataprotection@dandrcampbell.co.uk or you may go directly to the Information Commissioner's Office at https://ico.org.uk/concerns/
